DET. I gotcha. Alright. And so you and are working on the same building

throughout most of the day. Is that fair to say?

We started out, I wish I had a picture of the buildings. We started out

finishing...

DET. I'll get that.

I call building one where the office is.

DET. Uh huh.

Then building two and then building three. We finished up a little bit on building three and then building four over here, we finished one that

was over there and then we shipped it across the street.

DET. Okay.

Now mind you this was, uh, we got over across the street at eleven o'clock. About ten thirty and then that's where all the roots were. There, they, they cut down big trees right there. So I, we had to take the

thing and make turns and instead of just going straight out like normal...

DET. Yeah.

...and underneath the sidewalk but we didn't have, uh, we didn't have the machine over there, what we normally would do is try to channel underneath the- the sidewalk but we got bored with that because that...

DET. It's a pain.

...basically sucked.

DET. Yeah. Yeah.

So we started cutting, then we just lift the curb out and then dig a trench. Okay. Alright. DET. Under that, so, that one was, uh, the one that I was working on at eleven was the worst. DET. And where was that one at? West Florissant's over here. There's the, uh, leasing office right there. Yeah, this is one. DET. Yeah. And then this is two. We finished, and three, yeah, we-we-we pretty much knocked these ones out and then got over to here. DET. Okay. This is where I'm talking about where it was, uh, the root infested one. This is where I had o-originally talked to Michael. DET. Okay. And I was wrapping all that up and then when Michael and his little buddy took off, then we just drove the truck across to here and started on this one. DET. Yep. Well, when they left, he had walked over to here. This is where we store all of our stuff. This is where mine and 's little time are different. I'm a foreman and he not really a laborer so, I figure it took him about fifteen minutes to go up there and get the Bobcat to come over here. DET. Okay. And he figures it took a half hour. So I-I-I don't know. And when they left, that's, this is where I was at, my truck was parked right here. And he came over to dig out this one, dig out this one, and dig out that one. DET. Okay. As in like... ...well it's about, and he was just rolling it up. I said you're not gonna smoke it outta that are ya? Oh no, then that's when they took off. That's the last I've seen of 'em. DET. Okay. And, what else are we missing about this? 'Cause this, there's still a little bit more that, that we're missing. Not from me there's not. DET. Did you get any of his? Nope. I don't ... DET. Did you get... I'll pee in a cup right now. DET. ...did he get any of yours? My what? DET. I don't know, whatever it is that you had. No. I have nothing. There was no drugs from me at all. DET. Anybody else? No. I was working. DET. Okay. I understand. But I understand also that people can sometimes indulge when they're at work. And it's not, it's not any of my business...

My comment was, I wouldn't mind finding some wax.

DET. Uh huh. That's all I said. It has nothing to do with anything. DET. Okay, so when did Michael pull out this weed then? That's what he got when he was coming down going to the store and they were on their way out the door. DET. And it was rolled up in a white.... No. DET. ...piece of paper? It was folded in half, and then he started rolling it up when they were taking off. DET. Alright. Did you see anybody else with anything? Huh uh. DET. Dorian? Huh uh. DET. You? Huh uh. DET. Huh uh. I don't think does drugs at all. And I know I don't. DET. Okay. Have I? Yeah. I've done my share of all kinds of drugs. DET. Do you consider weed a drug? Anything that fucks ya up is a drug. DET. This isn't, this is about as open and up front as we can get. Alright. Dorian and Michael are together, correct when they come down the stairs? And are you talking to both of them...not specifically about weed or whatever, but you're talking to both of them at the same time? You with me? I didn't meet Darian until then I didn't even meet him then. DET. Right. But he come down the stairs and I said you brought help or something to... DET. Okay.to come down and help, and that's when the weed thing, he had was rolled up in there. DET. Okay. So, so Michael has the weed... Michael had the weed... So Michael has the weed and Dorian's over here next to next to each DET. other... Uh huh. DET. Right? They're next to each other. And then so you see the weed that Michael has and then you make a comment to Darian... All I say is I wouldn't mind finding some wax.

exchange, there was no hand shake, there was no fist pump, nothing, between us the whole time. There was, we just, I thought he was slow so I was playing, asking if he wants to shovel the whole time that we were talking and I just let him talk and then, it-it was, there was, it, nothing occurred to me. I was busy digging my little trench.

DET. So all this, this conversation that you had with-with, uh,...

The first half hour that-that was just, I was down on my knees digging a

hole while he was standing there watching me dig.

Alright. No one that, is there anybody that could have possibly seen something different of how long you two were standing there? Or you three, I'm sorry, you three where standing there talking? That's what we're, that's what we're trying to, uh, so are you... I can't answer that. DET. ...okay, if somebody, if something happens and there's multiple people that see whatever it is, a car accident or a bank robbery or anything, you would assume that everybody would see and ss-see the same thing or have a different perception of it. But, it would generally fit the same mold. Correct? If everybody's in the same location... Yeah. DET. ...that, then everything would kind of fit and be like okay, well he was standing at a different spot at the intersection when the car accident happened. Or they were at the transaction counter and saw the bank robbery happen over here so their p-views are going to be a little different. Correct? But, it would generally fit the same mold. Would you agree with that? Uh huh. DET. Okay. That's not happening right here when we're talking to you about

this second interaction that you had with Darian and Michael. That's what we're trying to- to understand and- and make-make it make sense

to us, because like Matt said, we're here trying to tell the story of the last two hours of Michael's life. And you play a critical role in that. Okay? You can provide us with critical answers that we cannot get from anyone else. It is you. this- this is the reality of it right now is that nothing is gonna change what happened. The only thing that's gonna change is the fact that we will have what happened the last moments of Michael's life and that's why you're sitting in this room and that's why we're talking to you. We want to understand it. And we need your help to understand it. Okay? There's no tricks, there's no games, there's no, there's nothing. It is your statement. You're time to tell us what happened. You're the only one that can do it. You're the only one that talked to Michael that day at any length of time. Help us understand it.

And did you say that you were, that you were sorry... DET. I try-I told her... ...for what happened? DET. Yeah. I was sorry for what happened. DET. Yes. Okay, and why did you tell her that? Because I was sorry for what happened. DET. Okay, and because you're a caring person, right? Yep. DET. And in order for us to get to that why, in order to find, for us to find out why something happens, it is critically important, it is so important for us to go back and to figure out what a person was doing in the last two hours of their life. Okay? And so here's what we're saying to you, okay. You obviously, you clearly had, clearly, clearly, clearly had a lengthy conversation with Michael Brown. Right? Right. Okay, and you had that conversation within that last two hours of his life. Right? Right. Okay. Did you kill Michael Brown? Of course you didn't. Of course you did not kill him. We all know what happened, alright?
