SA Um, first of all where were you at that day?

I was, first I was on the, I was across the way on this porch on the

second level.

SA Across the way on, in this building still?

Yeah.

SA Can you, from here, let-let's look at here, so, I believe we're in this

building right here, is that correct?

Yeah, uh huh.

SA Can you kinda show me at like star it where...circle the building and...

Yes.

SA ...and then star where you were at. And, I was like across the way from my building. But it's on the same building but I was like on-on this side of the building. SA Okay, so you were up-up in here. Right. Okay, like when you all came up that walkway and you can see the sidewalk lead to each side of the building, I was on that side at that building on the second floor when I-when I heard the first shot. SA Okay, so you were in this building though? Right. SA At the time. I was outside on the porch. SA Outside. On this side of the building or this side of the building? That side of the building. SA Right here? Right. SA Right where my finger is? Uh huh. SA That'd be a west side...the side facing Copper Creek is the (UI)? Right, uh huh. SA Okay. And um, when I heard the first shot, that's when I went down to the lot. SA What lot. Show me where you went. Well, I can't see the writing, put my eyes back on. SA Put this a little closer so we can hear ya.

	I came to, from here and I ran down to the lot 'cause I heard the shotat the tip of the lot.
SA	Okay. After-after you heard one shot?
	No, I heard two.
SA	You heard two shots?
	I heard two shots.

	And I, that's when I ran down to the lot to see what was goin' on.

I couldn't make out what he was sayin'. But, he was sayin' somethin', Michael was to the police officer. The police sayin' (UI) 'cause I'm slightly deaf in one year. So, I couldn't make out what they was sayin', so...while the police (UI) he just shootin'-shootin' right there and the bullet hit him right here. And, that's when he was goin' down and the police stand there and shot him again in his head. SA So he was-he was...how many shots you think he took in the head? I don't know. SA How many shots did you hear total? I got a total of nine. SA You heard a total of nine shots. Yeah. SA Okay, um, but you said, did he shoot him after he fell? Yep. He-he was goin' down that when he was shootin' he-he's like no, you ain't gonna plea me down but you almost down. SA Yeah. And, that's when the bullet hit him in the head. SA Okay. And he went on down. SA And then-then did the police officer stop shooting?

He didn't have no more rounds. The gun just stopped. Or, the gun said

SA Okay. Um, you understand that you-you're not allowed to lie to a federal officer? Yes, I know. You know it's a crime? SA A, who you tellin'? I know that. SA It's-it's a federal statute. Yes it is. SA (UI) I-I already know. SA Okay. Um, so you understand that if you lie to us and we prove it, that vou could... I already know all of that. And, that's one thing I don't do. Everybody tell you, I do not got no time to lie and I ain't gonna lie to you. If I'm gonna lie, I'm keepin' my mouth closed. SA Okay. But I'm just tellin' you what I saw. And then a, I ran in the house and I-I got all my (UI) 'cause I-I've been vomiting. Then I-I got myself back together. I went back out and he was just laying there. Just blood just running everywhere. SA O-okay And, a, they say on the radio move (UI) everybody had to move back. So, everybody moved back so they can get the body out of the street but the boy lay there for four hours uncovered. And then they finally covered him up and he laid there another hour and thirty minutes covered up. SA So, when you first went out there, when you first saw, after you heard the first shot, or two shots you said, you didn't, the first time you saw Michael Brown he was on his knees? Yes, that's the first time I saw him. He was on his knees.
