Did you ever see Michael Brown in...part of his body inside the vehicle or not?

No, I didn't. I only saw when the officer was holding on to him and kept pulling him towards his vehicle when Michael Brown was pulling to get away from his vehicle.

And that's when he got approximately ten – fifteen feet away...the officer let more shots go from inside of his vehicle. So...I guess, like the shots that he fired...they say he only shot one shot from inside his vehicle but it was more than one shot that was fired from inside of his vehicle, so I'm guessing the shots, that he..after he fired the first one, are like probably, ya know, hit him in his back or something....I couldn't actually see 'cause I was ducking. But...I say he got about ten or fifteen feet away...his friend was...after he had let them shots ranged out, his friend was ducked behind the police car.
